In determining the value of a portion of real property for purposes of determining whether a lien could be stripped, the Court concluded that the appropriate valuation was as of the petition date and that, therefore, an appraisal prepared closest in time to the bankruptcy petition and whose methods appeared to be the most reliable provided the most accurate valuation of the four appraisals submitted.
