**Adoption of Revised Schedule of  
Transcript Fee Rates**

---

In September 2007, the Judicial Conference approved an increase of ten percent to the maximum original and copy transcript fee rates that may be charged for court transcripts to be effective in fiscal year 2008, subject to the availability of funding. The Judicial Conference also approved a new rate for the delivery of transcripts within 14 days and agreed that the rate be set at the mid-point between the rates authorized for expedited (7-day) and ordinary (30-day) delivery, to be effective in fiscal year 2008. Pursuant to a Memorandum from the Director of the Administrative Office of the United States Courts dated October 18, 2007, implementation of these adjustments to transcript fee rates can take effect immediately upon adoption by the court of the new rates. Accordingly, it is ordered that:

1. Effective for all transcripts ordered on or after October 29, 2007, the court adopts a schedule of transcript fees subject to the maximum rates established by the Judicial Conference as set forth in the attached "*Notice of Judicial Conference Maximum Transcript Rates Effective October 29, 2007*".
2. Transcript orders placed prior to October 29, 2007 shall be billed at the rates established under this court's administrative orders setting transcript rates in effect on and applicable to the date the transcript was ordered.
3. This order replaces and abrogates Administrative Order 03-2, for purposes of establishing the current transcript rate in effect in this court.

<b><u>Ordinary Transcript</u></b> A transcript to be delivered within thirty (30) calendar days after receipt of an order.	\$3.65	.90	.60
<b><u>14-Day Transcript</u></b> A transcript to be delivered within fourteen (14) calendar days after receipt of an order.	\$4.25	.90	.60
<b><u>Expedited Transcript</u></b> A transcript to be delivered within seven (7) calendar days after receipt of an order.	\$4.85	.90	.60
<b><u>Daily Transcript</u></b> A transcript to be delivered following adjournment and prior to the normal opening hour of the court on the following morning whether or not it actually is a court day.	\$6.05	1.20	.90
<b><u>Hourly Transcript</u></b> A transcript of proceedings ordered under unusual circumstances to be delivered within two (2) hours.	\$7.25	1.20	.90
<b><u>Realtime Transcript</u></b> A draft unedited transcript produced by a certified realtime reporter as a byproduct of realtime to be delivered electronically during proceedings or immediately following adjournment.	\$3.05	1.20
