**(1) ENTRY OF ADMINISTRATIVE ORDER 15-01;
(2) AMENDMENTS TO MORTGAGE MODIFICATION MEDIATION PROCEDURES; AND
(3) AMENDMENTS TO LOCAL MORTGAGE MODIFICATION MEDIATION FORMS**

- I. Administrative Order 15-01 "Adoption of Interim Local Rule 4004-3(A)" was entered on March 31, 2015 to include reference to additional court requirements that may delay entry of a discharge of debtor.

- II. The court's Mortgage Modification Mediation Procedures have been amended to include the following changes which shall apply to any motion for referral pending on or after April 1, 2015 except that the provision in item one below shall only apply where the motion requesting MMM was filed after April 1, 2015. Any motion for referral filed after April 1, 2015 must be filed using the applicable revised MMM motion listed in this notice.
 1. New provision that participation by a chapter 7 debtor in MMM will result in delay of entry of a discharge for an otherwise eligible debtor pending completion of the MMM process
 2. A new section on trial payments during the MMM process.
 3. Amendment to include reference to chapter 12 cases regarding plans.
 4. Amendment to reflect modification of plan payment amounts.
 5. New provisions on application of MMM payments.

- III. The following MMM local forms have been revised effective April 1, 2015 to include the provision that participation by a chapter 7 debtor in MMM will result in delay of entry of a discharge for an otherwise eligible debtor pending completion of the MMM process. The forms have also been revised to require inclusion of actual names of parties to the MMM and address of the property subject to the MMM order.
