The Committee continued discussion regarding a law student outreach event including format, location, presentations, and potential attendees including former law clerks. Judge Isicoff suggested the Committee obtain and have available the pamphlet created by the National Conference of Bankruptcy Judges on the top 10 reasons to clerk for a bankruptcy judge.

# e. Language and Accessibility Subcommittee

The Committee discussed concerns relating to the need for translators to assist *pro se* debtors. While the U.S. Trustee program funds the use of a telephone service for 341 meetings, nothing similar exists for court hearings. Judges Kimball and Isicoff advised that there is no funding for interpreter services provided by the Court, and other limitations on the use of such services. The subcommittee determined to address the concern with the Pro Bono Committee.
