**Adoption of Policy Regarding Emergency
Closure of Courthouses In The Event of
Hazardous Weather Conditions**

On September 5, 2007, Administrative Order 2007-44 "In Re: Emergency Closure of Courthouse" was entered by Chief United States District Court Judge Federico A. Moreno. In order to achieve consistency with the United States District Court, it is

ORDERED that, absent any further order of this court, in the event of hazardous weather conditions that cause the local public schools within a particular county to close, the federal bankruptcy courthouse within that county will also close.



ADMINISTRATIVE ORDER 2007- 44



IN RE: EMERGENCY CLOSURE OF COURTHOUSE

In the event of hazardous weather conditions, including hurricanes and tropical storms, the Court hereby changes the previous uniform policy of closure of courthouses.

IT IS ORDERED that as of the date of this order, in the event of hazardous weather that causes the local public schools within a particular county to close, the Federal Courthouses in that county will also close. Thus, if Miami-Dade County public schools close, so will the Miami Federal Courthouses. If Broward County public schools close, so will the Broward Federal Courthouse. If Palm Beach County public schools close, so will the West Palm Beach Federal Courthouse. If St. Lucie County public schools close, so will the Ft. Pierce Federal Courthouse. If Monroe County public schools close, so will the Key West Federal Courthouse.

The clarity of this policy, the ease of obtaining the information on school closings, the Court's desire to have a family friendly environment, outweigh any detriment at not having a uniform district wide policy. This Order will supersede any prior orders on policy statements regarding closures or early dismissal. However, in the event an emergency,

whether related to weather or other causes such as fire, civil unrest, etc., the Chief Judge retains the discretion to close the Courthouses irrespective of any decision by the public school.
