**Adoption of Amended Schedule
of Transcript Rates**

At its September 2021 session, the Judicial Conference amended the Transcript Fee Schedule to simplify the billing process for realtime court reporting. The fee schedule amendment requires that orders for realtime transcript feeds placed on or before the day of the proceeding be batched together for billing purposes and that subsequent orders be charged at the lowest rate assessed on the previous orders. The Conference did not modify fee amounts for transcript pages. Accordingly, it is

ORDERED that effective immediately, the court adopts the attached "Schedule of Transcript Rates" in accordance with the maximum transcript rates established by the Judicial Conference.

It is further **ORDERED** that this order replaces and abrogates Administrative Order 2018-07 for purposes of establishing the current transcript rates in effect in this court.

<p><u>14-DAY TRANSCRIPT</u> A transcript to be delivered within fourteen (14) calendar days after receipt of an order.</p>	\$4.25	\$.90	\$.60
<p><u>EXPEDITED TRANSCRIPT (7-DAY)</u> A transcript to be delivered within seven (7) calendar days after receipt of an order.</p>	\$4.85	\$.90	\$.60
<p><u>3-DAY TRANSCRIPT</u> A transcript to be delivered within three (3) calendar days after receipt of an order.</p>	\$5.45	\$1.05	\$.75
<p><u>DAILY TRANSCRIPT</u> A transcript to be delivered on the calendar day following receipt of the order (regardless of whether that calendar day is a weekend or holiday), prior to the normal opening hour of the clerk's office.</p>	\$6.05	\$1.20	\$.90
<p><u>HOURLY TRANSCRIPT</u> A transcript of proceedings to be delivered within two (2) hours from receipt of the order.</p>	\$7.25	\$1.20	\$.90
<p><u>REALTIME TRANSCRIPT</u> A draft unedited transcript produced by a certified realtime reporter as a byproduct of realtime to be delivered electronically during proceedings or immediately following receipt of the order.</p>	<p>One feed, ¹\$3.05 per page; two-to-four feeds, \$2.10 per page; five or more feeds, \$1.50 per page.</p> <p>Orders placed on or before the day of the proceeding will be batched together for purposes of determining the number of feeds; and subsequent orders will be charged at the lowest page rate assessed on the previous orders.</p>		

¹ A realtime "feed" is the electronic data flow from the court reporter to the computer of each person or party ordering and receiving the realtime transcription in the courtroom.
