Adoption of Increase to Per Page Transcript Fee Rates	

In September 2022, the Judicial Conference approved an increase to the maximum per page original and copy transcript fee rates aimed at keeping pace with inflation. This will result in an approximate increase of 10 percent in each of the fiscal years 2024 and 2025. Accordingly, it is

#### **ORDERED** as follows:

- 1. Effective October 1, 2023, and October 1, 2024, respectively, for all transcripts ordered on or after these dates, the court adopts a schedule of transcript fees subject to the maximum rates established by the Judicial Conference as set forth in the attached "Notice of Judicial Conference Maximum Transcript Fee Rates".
- 2. Transcript orders prior to the effective dates reflected in the attached notice of this Order should be billed at the rates in effect at the time the order was placed.
- 3. Local Form *Transcript Request Form (LF-5)* will be amended effective October 1, 2023, and October 1, 2024, to reflect the new transcript fee rates.
