

ORDERED in the Southern District of Florida on December 16, 2014.



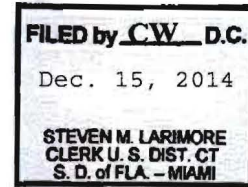
